O R D E R

During the discussion on Demand for Grant for Revenue the Minister (Revenue & Law) has announced on the floor of the Legislative Assembly about the Constitution of Taluk Sabha in the State as a step up to the existing Gramasabha to bring revenue administration closer to people.

2. In pursuance of the above announcement Government are pleased to constitute the Taluk Sabha as under and also issue further order for its conduct.

I. There shall be a Taluk Sabha at the Taluk level in all the Taluks in the state.

II. The composition of Taluk Sabha shall be as under (in where jurisdiction the Taluk falls), the Tahsildar concerned and such other officer as any be nominated by the Government will constitute the official members, Non – official will comprise of the Members of Parliament, MLAs District Councilors, Municipal Cheirman/Panchyath President – all representing the territorial jurisdiction of the Taluk and one representative each of the political parties having representation in the Assembly.

Government shall nominate such other officers as found necessary to the Sabha from the time.

III. The Taluk Sabha shall next on the 3rd Saturday of every month.

3. The District Collector Shall chair the meeting. In his absence the Deputy Collector who is in charge of the Taluk Sabha will chair.
4. The District Collector shall invariably attend one or the Taluk Sabha every month. Revenue Divisional officer/sub Collectors and Deputy Collectors shall attend the concerned Taluk Sabha every month. The District Collector Shall at last one of such officers to each Taluk for attending the ... of the Taluk Sabha and he shall be the charge officer of the Taluk Sabha Concerned.
5. The Taluk Sabha will address itself to the following:-
 - (i) All matters to be detail with the Taluk level.
 - (ii) All such other power of District Collector/Revenue divisional officer/Deputy Collector as will be delegated by Government from time to time
 - (iii) Any other function as may be delegated by various Department of the Government undertaking, Authorities etc. from time to time.
 - (iv) Any other matter of public interest as may have to be development by the Taluk Sabha.
 - (v) All matters refereed from the Grama Sabha.
6. The Taluk Sabha shall maintain a register for recording the proceedings of the meeting. The convener of the Taluk Sabha shall forward a summary of the proceedings of the Taluk Sabha to the District Collector in turn, shall forward a summary of the proceedings of the various Taluk Sabha in his District to the Government in Revenue Department resistively before the 30th of the month.
7. The District Collector and Tahsildar shall from separate collect the District & Taluk levels for co-coordinating the activities of the Taluk Sabha and for processing the petition received from the public etc.

8. All District Collector will take urgent steps for the proper implementation of this order so as to ventilate public effectively.
