# $\underline{O} \underline{R} \underline{D} \underline{E} \underline{R}$

Government as per the order read as first paper above have accorded sanction to de - link the 15<sup>th</sup> Livestock Census from the Socio – economic Survey and to conduct it independently.

Accordingly the Director of Animal Husbandry per his letter read as second paper above has furnished a proposal for the conduct of the Census form 15<sup>th</sup> to 30<sup>th</sup> January, 1996.

Governments have examined the proposal in detail and are pleased to order as follows: ----

i. The  $15^{\text{th}}$  Quninquennial Livestock Census will be conducted with the participation and full co – operation of the authorities of Local Bodies.

ii. A one tome special allowance of Rs. 100/- will be paid to the Secretaries of Grama Panchayats/municipalities/ Corporations who are directly involve in the Census Work

iii. The selection of enumerators will be done as follows: ---

The Senior Veterinary Surgeons/ Veterinary Surgeons in each Panchayat/ Municipalities/ Corporation will collect applications from educated unemployed Youth after giving wise publicity by publishing a notice in Notice Boards of the Grama Panchayats/ Blocks Panchayats/ District Panchayats/ Municipalities/ Corporations offices and of the institutions of the Animal Husbandry Department. They will present the list of applications along with the applications received to the Grama Panchayat President/ Municipal Chairman corporation fayour and selection with the District Animal Husbandry officers of the Districts concerned. The authorities of the local bodies will issue a letter of authorization to the enumeration and a copy of the list of selected candidates will be forwarded to the District Animal Husbandry Officer concerned.

iv. The engagement of the enumeration will be temporary and they will be terminated as and when the enumeration process is over.

v. The enumerators will furnish a written declaration that he/ she will conduct the enumeration with accuracy and the schedules will be filled in and hand over to the concerned officers immediately after the enumeration is over, and his/ her engagement as enumerators will not be projected as a claim for any appointment in the Animal Husbandry Department in future.

vi. The preliminary work relating to the enumeration of census date wiz. Conducting training classes for the enumerations collection of the filled up schedules, supervising the census operators, compling and analyzing the census date will be done as ordered in the G.O.MS.No. 122/95/AD dt. 25.3.1995
