

G. O. (P) No. 26/2009/F&WLD.

Dated, Thiruvananthapuram, 5th June, 2009.

S. R. O. No. 445/2009.—Wittereas, the Government of Kerala consider that the area, the situation and limits of which are defined in the Schedule below is of adequate ecological, faunal, floral, geomorphological, natural and zoological significance;

AND WHEREAS, it appears to the Government of Kerala that the said area is needed to be constituted as a Wildlife Sanctuary for ensuring long term conservation of the entire biodiversity of the area;

Now, Therefore, in exercise of the powers conferred by sub-section (1) of section 18 of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972), the Government of Kerala hereby declare their intention to constitute the said area as a Wildlife Sanctuary to be known as "Malabar Wildlife Sanctuary".

Situation and limits

- North:—Start from a point which is 4.124 km, towards the East on the Northern boundary of Pannikottoor Reserve Forests from the meeting point of North-Western corner of Pannikottoor Reserve Forests and Kuttiady River and then proceeds along the Northern boundary of Pannikottoor Reserve Forests till it reaches the Kozhikkode-Wayanad inter-district boundary.
- East:—Thence the boundary proceeds generally towards south and in Southeast direction along the Kozhikode-Wayanad inter-district boundary till the point where the Kozhikode-Koyilandy Taluk boundary meets the inter-district boundary.
- South:—Thence the boundary proceeds in a South westernly direction along the Kozhikode-Koyilandy Taluk boundary till the point where the common boundaries of forests in Vested Forest Committee item No. 5 (in Survey No. 912) and bit number 27 of Vested Forest Committee item No. 52 touches the Taluk boundary.
 - West:-Thence the boundary proceeds towards northern direction along the common boundaries of the forest in Vested Forest Committee item No. 5 and in bit numbers 27 of Vested Forest Committee item No. 51 till it reaches the boundary of Kakkayam Reservoir in Survey No. 911 and further proceeds along the common boundary of forests in bit numbers 27 and 31 of Vested Forest Committee item No. 52 and the Kakkayam reservoir till it touches the Kakkayam Forest and further it proceeds to a Western direction along Southern boundary of Kakkayam forest, and along the stream and then proceeds further along Western boundary of Kakkayam Forest till it meets Onipuzha and the Southern boundary of Pannikkottoor Reserve Forest and then the boundary further proceeds towards Western direction along the Southern boundary of Pannikkottoor Reserve Forest and then proceeds in the North Western direction along the Eastern boundary of the land leased out to Indian Institute of Spices Research till it reaches the North Eastern corner of the land leased out to Indian Institute of Spices Research and then proceeds in North Eastern direction through 1960 soft wood (Ailanthus species) Plantation for a distance of 1179 m. till it reaches the starting point.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The richness of biodiversity and conservational significance of the Government Forests of Kakkayam (Sy. No. 805) and Pannikottoor (Sy. No. 568) Reserve Forests and Vested Forests in Vested Forest Committee item No. 55 in Sy. No. 902/pt. (Karamparamala), Vested Forests in Vested Forest Committee item No. 5 (Bits Nos. 2, 5, 7 and 9) in Sy. No. 902/pt. (Olathukkimalavaram) and Vested Forests in Vested Forest Committee item No. 5. (Bit No. 7) Sy. No. 912 (Sankaranpuzha and Athikkode Vested Forests) have been identified by various scientific agencies. The Government finds it necessary to declare the area as a 'Wildlife Sanctuary' for protecting its ecological, faunal, floral, geomorphological and natural wealth for ensuring its long term conservation. Therefore, the Government have decided to declare its intention to constitute the said forest area including the Kakkayam Reservoir (extent of 283.5656 ha.) in Sy. No. 911, extending to total 7421.5015 ha. as a Wildlife Sanctuary. Since the rights over the said Reserve Forests as well as vested forests are yet to be settled, the Government have also decided to notify the proposed Sanctuary under sub-section (1) of Section 18 of the Wildlife (Protection) Act, 1972.

This notification is intended to achieve the above object.
