NOTIFICATION

G. O. (P) No. 81/05/F&WLD. Dated Thiruvananthapuram, 23rd August, 2005.

S. R. O. No. 851/2005.—In exercise of the powers conferred by sub-section (1) of section 5 of the Kerala Preservation of Trees Act, 1986 (35 of 1986), the Government of Kerala hereby direct that no tree standing in the area specified in the Schedule below, shall be cut, uprooted, burnt or otherwise destroyed except on the ground that—

- (a) the tree constitutes a danger to life or property; or
- (b) the tree is dead, diseased or wind-fallen.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The area included in the schedule to the Notification comprised in the Forest Division, Palakkad and involved in OA No.1391/74 of the Forest Tribunal, Palakkad is a private forest and form part of Kulakkadan Mala. The lands, on restoration, are likely to be cleared by felling all the available trees there, which will adversely affect soil conservation and moisture retention in the area. Therefore, it has been decided to bring the area under the purview of section 5 of the Kerala Preservation of Trees Act, 1986 for preservation trees and tree growth.

The notification is intended to achieve the above object.
