TO FLOOD VICTIMS- ORDERS ISSUED

ORDER

With a view to giving some relief to the victims of the recent floods in the state who have taken House Building Advance from Government under the scheme laid down in the Kerala Financial Code, Government are pleased to issue the following orders.

1 In cases where the house built by Government servants utilizing a loan from Government under the scheme laid down in the Kerala Financial code have been considerably damaged in the recent floods in the State recovery of the loan will be suspended for a period of six months beginning from the bill for December, 1978 .The suspended instalments will be recovered extending the period of recovery already fixed by six months subject to the conditions that the period of recovery should not go beyond the date of superannuation of the loanees. In case where the full amount cannot be recovered before the retirement of the loanee consequent on such extension of period of repayment, the amount of each instalment after the suspended period of recovery should be suitably refixed. The authority competent to sanction the loan as specified in Article 244B of the Kerala Financial Code will issue necessary sanction in this regard. A letter of consent agreeing to refix the amount of instalment accordingly will be obtained from the loanee in such cases. The loanee who wish to avail themselves of this concession may apply to their Heads of Departments or to the Governor in the Finance Department through the Head of Department, as the case may be, with a certificate obtained from the Tahsildar of the Taluk where the house is situated, in the form appended to this order with the consent letter mentioned above where necessary.

2. The loanee whose residential house have been damaged in the recent floods and who are in need of money for their repairs will be sanctioned an advance not exceeding six months their basic pay or the actual amount required for repairs whichever is less subject to all other conditions laid down in the rule 11 in section "D" OF Article 244 C of the Kerala Financial Code on production ncessary certificate from the Assistant Engineer, Buildings and Roads branch of public Works Department having jurisdiction over the area where the house is situated. Acertificate from the Tahsildar in the form of appended t o this order should also be produced along with the application. The loanees who desire to avail themselves of this facility should submit their application. The loanees who desire to avail themselves of this facility should submit their application before 15-2-1978 to their Heads of Department. The Heads of Departments after scrutiny of the application will report the details of such applications and requirement of funds before 26-12-1978 positively. The details should be reported in the following proforma;-

- 1.Name and designation of the loanee;
2. Pay of the loanee;
- 3.Amount of advance applied for;
- 4.Amount Certified by the Assistant Engineer;
5. Amount he is eligible for under the rules;
