Sub;- Advance- House Building Advance to Government Servants-Statements of requirement of funds for 1984-85- instructions issued.

All the heads of Departments/ Sanctioning authorities are directed to furnish on or before 31-5-1984 statements of requirement of funds for house building advance for 1984-85 in the proforma appended in respect of the following:

- (i) Application from class-IV employees towards original advance from 1-4-1982 to31-3-1983.
- (ii) Applications from physically handicapped employees who have 40% disability and are getting special coveyance allowance of Rs.50 per mensem. The applications from 15-9-1980 to 31-3-1983 may be furnished in such cases.
- (iii) Application from employes other than Schedule Castes and Scheduled Tribes towards additional advances (Completion/Extesion/Repairs) received up to 31-31984.
- (iv) Application from Scheduled Caste/Scheduled Tribe employees towards additional advance (Completion/Extesion/Repairs) received up to 31-3-1984.
- (v) Applications for which advance was allotted/sanctioned during 1983-8, but could not be drawn and disbursed on account of the economy orders in G, O (P) NO 141/84/Fin, dated 7-3-1984
