NOTIFICATION

S.R.O No. 183/71 – In exercise of the powers conferred by the to Article 320 (3) of the constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Public Service Commission (Consultation) Regulation, 1957, published in Kerala Gazette No. 15 dated the 9th April. 1957. as subsequently amended, Namely:-

AMENDMENT

In the Annexure to the said Regulations, for item 5 under the heading “Subordinate services” the following shall be substituted, namely:-

“5 Appointments of personnel retrenched from a post within two years of such retrenchment to a post carrying the same or lower scale of pay, either in the same service or in another service, provided the qualifications required of the post are in the opinion of Government, similar those in the retrenched post

Explanatory Note

(This note is not part of the amendment but is intended to indicate its general purport.

Under Regulation 4 (b) of the Kerala Public service Commission (Consultation) Regulations, 1957 read with item 5 under “Subordinate Services” to the Annexure thereto it shall no be necessary for the Public Service Commission to be consulted as respects any of the matters mentioned in Article 320(3) (a) and (b) of the Constitution of India ie. “appointments of personnel retrenched from one service to another service within two years of retrenchment, where the qualifications required are, in the opinion of Government , similar to those in the retrenched service.” This provision does not however, permit the appointment of personnel retrenched from a post in one service to another post in the same service, though the qualification may be similar. It is considered appropriate and necessary to enable the appointment of personnel retrenched from a post in a service to another post in the same service also within to years of retrenchment where

the qualification require are the same. The notification is intended to amend the Regulations to achieve the above object.
