NOTIFICATION

S.R.O. No. 700/77.- In exercise of the powers conferred by article 318 of the Constitution of India , the Governor of Kerala hereby makes the following amendment to the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations, 1957, published in the Kerala Gazette dated 5.3.1977 as subsequently amended namely:-

AMENDMENT

In the said Regulations, the following note may be added at the end of regulation 5B namely:-

Note:- The Government may be order appoint a Medical Officer to attend to the Chairman and Member of the Commission and their families at their residence.”
This amendment shall be deemed to have come into force with effect from 7.1.1977

Explanatory Note

(This note is not part of the notification, but is intended to indicate its general purport).

According to the existing provision in the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations, 1957, the Chairman and Members of the Commission are eligible for the same medical benefits as are allowed to the Gazetted Officers of the State Government which do not include free medical attendance at their residence by a medical officer appointed for the purpose. Government consider that the Chairman and Members of the Commission should have the facility of free medical attendance at their residence. Accordingly is G.O. Ms. No. 177/77/PD dated 7.1.1977 sanction was accorded for the appointment of a Medical Officer as attending Medical Officer to the Chairman and the Members of the Commission. It is necessary to give it statutory validity by incorporating suitable Provision in the said Regulations. The notification is intended to achieve the above object.
