S.R.O. No. 457/79.- In exercise of the powers conferred by Article 318 of the Constitution of India, the Governor of Kerala hereby makes the following amendments to the Kerala Public Service Commission (Composition and conditions of Service of Members and Staff) Regulations, 1957, namely:-

AMENDMENT

- 1. Short title and commencement. (1) These regulations may be called the Kerala Public Service Commission (Composition and Conditions of service of members and Staff) Amendment Regulations, 1979.
- (ii) They shall be deemed to have come into force with effect on and from the 7th day of January,1977.
- Amendment of Regulation 5B.- in the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations. 1957, regulation 5B shall be renumbered as sub-regulation (1) thereof, and –
 - (a) in sub-regulation (1) as so renumbered, the Note shall be submitted;
 - (b) after sub- regulation (1) as so renumbered, the following sub-regulation shall be inserted, namely:-

"(2) The Chairman and the other member of the Commission and their families shall be eligible to medical attendance at their residence by a Medical Officer appointed by the Government for the purpose

(3) Not withstanding anything contained in the Kerala Government servants' Medical Attendance Rules, 1960, the countersignature of the Medical Officer appointed under sub-regulation(2) shall be deemed as sufficient authority for reimbursement of the claims preferred by the Chairman and the other Members of the Commission, irrespective of the period of treatment and the amount of the claim."

Explanatory Note

(This note is not part of the amendment, but is intended to indicate the general purport)

According to regulation 5B of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations 1957, the Chairman and Members of the Commission shall be eligible to the same medical benefit and concessions as are allowed to the Gazette Officers of the State Government. They have, therefore to observe all the formalities prescribed in the Kerala Government servant's Medical Attendance Rules, 1960, while preferring a reimbursement claim under regulation 5B of the Kerala Public Service Commission (Composition and conditions of Service of Members and Staff) Regulation, 1957. The note under the said regulation provides that government may by order appoint a Medical Officer to attend to the Chairman and Members of the Commission at their residence. It is therefore, considered expedient to lay down that not withstanding anything contained in the Kerala Government Servant's Medical Attendance Rule,1960 the countersignature of the Medical Officer so appointed shall be deemed as sufficient authority for reimbursement of the claims preferred by the Chairman and Members of the commission, irrespective of the period of treatment and the amount of the claim. This notification is intended to achieve the above object.
