S.R.O. No. 951/85.- in exercise of the powers conferred by the proviso to clause (3) of article 320 of the Constitution of India, the Governor of Kerala hereby makes the following regulations further to amend the Kerala Public Service Commission (Consultation) Regulations, 1957, namely:-

REGULAIONS

1. Short title and commencement:- (1) These Regulations may be called the Kerala Public Service Commission (Consultation) Amendment Regulations, 1985.

(2) They shall come in to force at once.

2. Amendment of the Regulations- In the annexure to the Kerala Public Service Commission (Consultation) Regulations. 1957:-

(i) Under the heading "State Services", after item 13, the following item shall be added, namely:-

"14. Appointment in the vacancies to the posts of Assistant Engineer, Assistant Surgeon and Sales Tax Officer from outstanding Sportsmen/Women subject to the condition that the total number of such appointments in a year in the State Services plus appointments in the Subordinate Service (including Last Grade Service) shall not exceed twenty.

(ii) under the heading "Subordinate Services" after 23, the following item shall be added, namely:-

"24. Appointments in the vacancies to the posts mentioned below form outstanding sportsmen/ Women subject to the condition that the total number of such appointments in a year in the State Service plus appointments in the Subordinate Service (including Last Grade Service) shall not exceed twenty.
