S R O No. 822/79- In exercise of the powers conferred by the proviso to clause (3) of the article 320 of the Constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Public Service Commission (Consultation) Regulations, 1957, namely:-

AMENDMENT

1. Short title and Commencement- (a) These Regulations may be called the Kerala Public Service Commission (Consultation) Amendment Regulations, 1979
(b) They shall come into force at once .
2. Amendment to the Regulations, - IN the Kerala Public Service Commission (Consultation) Regulations, 1957, in the Annexure, in item 8 under the heading “Subordinate Services” sub-item (i) shall be omitted .

Explanatory Note

(This note is not part of the notification, but is intended to indicate its general purport)

According to sub item (1) of item 8 under subordinate services in the Annexure of the Kerala Public Service Commission (Consultation) Regulations 1957 among others recruitment to all posts below the rank of Sub-Inspectors in the Police Subordinate service may be made without reference to the Public Service Commission.

Government now propose to bring the recruitment of all Police officers below the rank of Sub-inspectors also within the purview of the Public Service Commission Sub item (1) under Item 8 has therefore to be deleted. This notification is intended to achieve the above object.
