#### **NOTIFICATION**

S R O No. 93/71- In exercise of the powers conferred by sub – section (1) of Section 2 of the Kerala Public Services Act, 1968 (19of1968) the Government of Kerala hereby makes the following amendment to the Kerala State and Subordinate Services Rules, 1958, namely;-

#### **AMENDMENT**

In Part II of the said Rules, after rule13 A, the following shall be inserted namely;-

"13 B. Not withstanding any thing contained in these rules or in the Special Rules, persons in Government Service who attain the age of 50 years and who have put in 25 years of service shall be eligible for permanent exemption from passing the obligatory departmental tests for all purposes such as promotion, appointment as full member of a Service, etc.

Note;-Military service and service rendered in posts which do not require test application shall be counted for calculating the 25 Years of service for granting such permanent exemption ".

### **Explanatory Note**

(This note is not part of the amendment but is intended to indicate general purport)

According to existing orders officers in Government service who attain the age of 50 and have put in 25 years of service will be eligible for permanent exemption from passing the obligatory departmental tests for all purposes such as promotion, appointment as full member of a service etc. Military service and service rendered in posts which do not require test qualification shall also be counted for calculating the 25 years if service for granting permanent exemption. Executive orders in this regard have been issued from time to time. It is considered necessary to give statutory validity to the above orders by incorporating necessary provisions in the Kerala State and Subordinate Services Rules, 1958. This notification intended to achieve the above abject.
