#### **NOTIFICATION**

S.R.O.No. In exercise of the powers conferred by Sub-section (1) of Section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following further amendment to the Kerala State and subordinate services Rules,1968,namely:-

## **AMENDMENTS**

In Part II of the said rules-

- (i) In rule 8-
- (a) the works, "subject to his completing satisfactorily the period of probation on his return shall be omitted.
- (b) In the proviso for the words, "provided that the words" provident further that "shall be substituted, and before the proviso as so amended the following proviso shall be inserted, namely:-
  - "Provided that subject to the provisions of rule 18 the shall satisfactory complete the period for probation on his return"
  - (2) after sub rule (e) of rule 18, the following sub-rule shall be inserted namely:-
  - "(f) A probationer in a service or a class of category of service deputed to discharge the duties of another post shall be eligible to count for probation the period of such deputation if the appointing authority is satisfied that the duties attached to the post to which he is deputed are allied to the duties of the post in which he is a probationer".

#### **EXPLANATORY NOTE**

(This is note is not part of the amendments but is intended to indicate its general purport)

The Kerala State and subordinate services rules,1958 do not contain any specific provision to make eligible a probationer in a service or a class or category of service deputed to discharge the duties of another post to count the period of such deputation

for purposes of completion of probation when the duties attached to the post to which he is deputed are allied to the duties of the post in which is a probationer. It is considered necessary that a general provision may be made in the Kerala State and subordinate services rules 1958 to ensure that persons deputed for doing duties which are allied to their original duties are per\*\*tted to count the period of deputation towards their probation, This notification is intended to amend the above rules to serve the purpose.
