S R O No.145/76-In exercise of the powers conferred by subsection (1) of section of 2 of Kerala Public Services Act,1968 (19 of 1968),the Government of Kerala hereby make the following amendment to the Kerala State and Subordinate Rules, 1958, namely;-

AMENDMENT

In part II of the said rules, in clause (C) of rule14, after the second proviso the following further proviso shall be added at the end, namely;-

"Provided also that in preparing the list of eligible candidates to be appointed under this rule applying the rotations specified above in every of 20 vacancies, the candidate eligible to be selected on open competition basis, that is,turns1,3,5,7 9,11,13,15,17 and 19 shall be selected first and then the candidates for the reservation turns, out of those available in the ranked list in the particular groups having regard to their ranks. In finalizing the select list any candidate of the same community selected from the same community on the basis of reservation, for the fixation of ranks as per rule27 of these rules, candidates of the same community obtaining higher marks shall be interchanged with the candidates of the same community in the reservation turn for the purpose of ranking.

Note;- This amendment shall be deemed to have come in to force with effect from 17-12-1958"

Explanatory Note

(This note is part of the notification but is intended to indicate the general purport.)

The procedure regarding the implementation of the principal of communal rotation in the selection of candidates for advance from the ranked list prepared by the Public Service Commission has been laid down in the Travancore – Cochin Government Order No S2-15238/50/ CS Dated 26-2-1953. It has been brought to the notice of the Government that the provisions in the above have not been in cooperated in the General rules for the Kerala State and Subordinate Services Rules,1958 and therefore have no statutory validity. In the circumstances Government have to decided in the consultation with the Kerala Public Service Commission to give statutory validity to the provisions in the G O dated26-2-1953 by amending the General Rule14 of the Kerala State and Subordinate Services Rules, 1958 with retrospective effect. This notification is intended to achieve the above object.
