NOTIFICATION

S R O No 543/77- In exercise of the powers conferred by sub section (1) of section of the Kerala Public Services Act, 1968 (19 of 1968) read with Section 3 thereof, the Government of Kerala hereby make the following amendment to the Kerala State and Subordinate Services Rules, 1958, namely:

AMENDMENT

In Part II of the said rules in clause (1) of sub rule (a) of rule 9 after the second proviso the following further proviso shall be inserted, namely :

Provided also that a person appointed under this clause by direct recruitment to a teaching post shall be allowed to continue, subject to availability of vacancy, till the closing date of the institution for the annual vacation or till a candidate advised by the Public Service Commission Joins duty, Whichever is earlier.

This amendment shall come into force from the date of order.

**Explanatory Note**

(This note is not part of the amendment but is intended to indicate its general purport. )

According to the second proviso to rule 9(a) (i) of the General Rules persons appointed under that rule by direct recruitment to apopst other than teaching post cannot be allowed to continue in such posts for a period of exceeding three months. According to orders issued I G O (P) 324/73/PD/dated 22/12/1973 and as clarified in G O (P) 113/74/P{D dated 06/05/1974 persons appointed on a provisional (temporary) basis through the employment Exchanges to teaching posts in educational institutions can be allowed on continue, subject to availability of vacancies till the end of the academic year or till the Public Service Commission recruited join duty , whichever in earlier.

But it has since been pointed out that academic year includes vacation also and so it will not be in order to relieve the provisional (temporary) teachers on the date of closing of the schools for the annual vacation unless specific provision to that effect is included in the Rules . The above notification is intended to achieve that object.
