IAS probationers – programme of training in the State – Revised Orders issued.

With a view to improve the teaching of Malayalam language to the AIS Officers allotted to this State Cadre form other States, Government have drawn up a scheme for the conduct. The proposed classes will be conducted by the State Institute of language, Trivandrum for which the probationers are to be available in Trivandrum for a period of six weeks in succession. It has therefore been found necessary to make some alternations in the sequence of the training programmes for IAS probationers in the State issued in the G.O. read as Ist paper above. The modified programme of training will be followed for the IAS Probationers of 1986 batch onwards.

- 2. According to the present scheme of training, the first item of training at the Institute of Management in Government, Trivandrum is followed by a 3 weeks survey training at the State Headquarters after which the probationers proceed to their Districts of posting for undergoing the remaining part of the programme. In the modified schedule of training on the Sales tax and Excise, the Industries and the Labour Departments, which are at present held at the Districts, will also be arranged at the State Headquarters (Trivandrum) in continuation for the survey training, so that the probationers will be available in Trivandrum for six weeks in succession. These programmes would take only half the day and remaining 3 hours of the day, will be utilized for the language training.
- 3. There will be no change on the other items of training and they will be followed as prescribed in the G.O. (MS) 107/84/GAD. Dated 4.4.1984.
