NOTIFICATION

S R O No454/80; In exercise of the powers conferred by subsection (1) of section 2 of the kerala public service act, 1968(19 of 1968) read with section 3 thereof the Government of kerala hereby make the following amendment to the kerala state and subordinate service rules 1958 namely;

AMENDMENT

1. Short title and commencement- (1) these rules may be called the kerala state and subordinate services (amendment) rules 1980  
(2) They shall come into force at once.
2. Amendment to rule 13b- In part II of the Kerala State and subordinate services rules 1958 in rule 13b
  - (i) in the Note after the words “private college service to the credit of teachers of government colleges” the words “palace services to the credit of the former palace employees absorbed in the Government service shall be inserted.
  - (ii) after the Note the following shall be inserted namely;  
“Explanation- The expression ‘palace employees ‘ shall mean person who were employed in the Travancore Palace or in Cochin Palace and who were absorbed in Government service by specific orders of the government and recorded as such in their service books”.

**Explanatory Note**

(This note is not part of the amendment but is intended to to indicate its general purport).

Government consider that the palace service if any to the credit of the former palace employees absorbed in Government service should also be counted for reckoning the minimum period of service of 25 years prescribed in rule 13B in part II (General Rules) of the Kerala State and subordinate Service s rules 1958 for eligibility for permanent exempted from passing obligatory departmental testes. This notification is intended to achieve the object.
