NOTIFICATION

S.R.O.No. 564/77 – In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968). Read with section 3 thereof, the Government of Kerala hereby make the following amendment to the Kerala State and Subordinate services Rules, 195, namely:---

AMENDMENT

In Part II of the said Rules, in rule 13B, after the second proviso, the following proviso shall be inserted, namely:--

"Provided also that ex-servicemen employees of the Rajya Sainik Board Department who attain the age of 45 years and who have successfully completed probation shall be per frequently exempted from passing the tests prescribed for promotion irrespective of the period their service".

The amendment hereby made shall be deemed to have come into force with effect on and from the 1st day of March, 1964.

EXPLANATORY NOTE

(This note is not part of the Notification but is intended to indicate its general Purport)

Government in G.O. (Rt.) No. 3117/PD dated 15-11-1966 grated permanent exemption from passing Account Test to those in service in the Rajya sainik Board (former S.S & Boards) who had completed 45 years on 1-5-1964 and also allowed temporary exemption for 4 years from 1-3-1964

And also allowed temporary exemption for 4 years from 1-3-1964 to those who had bit completed 45 years. Subsequently in G.O.(Rt) No 253/71/PD dated 22-1-1971 permanent exemption was granted to those who entered service after 1-3-1964 and above 45 years of age o9n the date of appointment . This exemption was ordered to be given effect to from the respective dates of entry in service of ,such persons. It has since been pointed out that this G.O. (Rt.) No. 253/71/PD dated 22-1-1971 has caused a grave anomaly resulting in hard ship to many employees. The above G.O. regarding permanent exemption is dated 22-1-1971 and it is to take effect from 1-4-1964 person appointed after 1-3-19*64 at age below 45 years are in eligible for permanent exemption and they would be superseded for promotion by persons who entered service subsequently but after completing 45 years.

The question of rectifying the above anomaly has been examined in details. It is now proposed to incorporate a provision in General Rule 138 of the Kerala State and Subordinate Services Rule, 1958 to the effect that ex-servicemen employees of the State Rajya sainik Board who attain the age of 45 years and who have successfully completed probation. This notification intended to achieve the above object.
