NOTIFICATION

S.R.O.No.820/81.—In exercise of the powers conferred by subsection (1)of section 2 of the Kerala Public Services Act, 1968 (19 of 1968)read with section 3 thereof, the Government of Kerala hereby make the following Rules further to amend the Kerala State and Subordinate³ Services Rules, 1958, namely:-

RULES

1. Short title and commencement –(1) These rules may be called the Kerala State and Subordinate Services, (Amendment) Rules,1981

2. Amendment to rule 10.-In part II of the Kerala State and Subordinate Services Rule^{3s}, 1958, in sub-rule (aaaa) of rule 10,

i. for the figure and word “4 years” wherever they occur, the words :six years” shall be substituted:

ii. for the words :four years” wherever they occur, the words six years” shall be substituted:

iii. before the Explanation the following proviso shall be inserted, namely:-

“Provided that a person referred to in this sub-rule who has been in service for more than four years on the date of commencement of the Kerala State and Subordinate Services amendment Rules, 1981 pub lish^{e3d} under notification No. G.O.(P) 194/81/GAD dated 12-6-1981, shall be allowed to pass the language test in Malayalam within a period of two years from the said date, if he has not already passed the test.

Explanatory Note

(This note does not form part of the notification but is intended to indicate its general purport.)

Ever since the introduction of sub-rule (aaaa) of rule 10 in the Kerala State and Subordinate services Rules, 1958 there have been persistent demands for the withdrawal of the same. Having examined the regional and other aspects involved in the matter and also the severity of the punishment contemplated in the above sub-rule, in consultation with the Kerala Public Service Commission, Government decided that the maximum period of 4 years allowed to the Linguistic Minority Officers who take their recruitment tests in Malayalam be extended to 6 years and that those linguistic minority officers in service for more than 4 years and who have not so far passed the language test be allowed a period of 2 more years from the date of issue of order for passing the test. This notification is intended to achieve the above object.
