In part II of the said rules in the note to rule 13b after the works "Military Service" he following shall be mastered namely;-

"and service rendered in aided schools local bodies and Universities work establishment service of fall time work establishment employers absorb into Government service or recruited by the public service commission , private college service to the credit of teachers of Government college"

Explanatory Note

(This note is note part of the amendment, but it is intend to indicate its general purport)

It is necessary to give statutory validity to the orders in G.O.(P) No 147/71/PD dated 23-12-1971 according to which service rendered in aided schools, local bodies and universities and work establishment service of the full time work establishment employees absorbed into Government service and of the full time work establishment employees recruited by the public service commission shall also counted for reckoning the minimum period of service of 25 years prescribed in rule133 in part II (general rules) of the kerala state & subordinate service rules 1958 for eligibility for permanent exempt on form passing obligatory departmental tests. It is also considered necessary to reckon the private college service if any available to the credit of the teachers of the government colleges for the above purpose.

This notification is intended to achieve the above object.
