#### NOTIFICATION

S R O No.339/81-In exercise of the powers conferred by subsection (1)of section 2 of the kerala public service act,1968 (19 of 1968) read with section 3 thereof the government of kerala hereby make the following amendments to the kerala state and subordinate services rules 1958, namely-

# AMENDMENTS

Short title and commencement;-(1) These rules may be called the kerala state and subordinate services (Amendment) Rules 1981
(2) They shall some into force at once

(2) They shall come into force at once.

2. Amendments of General Rules; - In part II of the kerala state and subordinate service rules1958

(i) in sub rule (a) of rule 9 in clause (i) after note (2) under the first provision the following note shall be added namely;-

(3) The expression "persons who are admittedly senior" in the above provision shall include persons appointed /prompted temporarily and continuing as such solely due to administrative delay in regularizing their appointments"

(ii) in sub rule (a) of rule 31 in clause (i) after note (2) under the existing provision the following note shall be added namely;

(3) The expression "person who are admittedly senior" and continuing as such solely due to administrative delay in regularizing their appointments."

## **Explanatory Note**

(This note does note form apart of the notification but is intended to indicate its general purport.)

At present the Deputy Tahsildars of the Revenue Department who are temporary appointed by transfer and continuing as such are not considered for promotion (appointment by transfer) as Tahsildars but at the same time those persons who were directly recruited as Deputy Tahsildars long after their appointment are considered for appointment as Tahsildars by virtue of the fact that the direct recruitment having got regular appointments as Deputy Tahsildars could complete their probation in that category whereas those appointed by transfer under rule 9 (a) (i) of the General Rules as Deputy Tahsildars could not complete their probation as their appointments have not been regularized for no fault of theirs, but solely due to administrative delay. Also, these persons have no seniority in the post as they do not hold regular appointment in the post. So to tide over the situation and thus to safeguard the interest of the temporary Deputy Tahsildars having longer service than the direct recruits for appointment on transfer and similarly placed persons in other Department it is proposed to amend General Rules 9 and 31 of the Kerala state and subordinate service rules 1958

This notification is intended to achieve the above object
