ORDER

1. According to the G.Os read above the following powers have been delegated to the Chief Conservator of Forests, Conservators of Forests and Divisional Forest Officers in respect of silvicultural works.

- 2. But in G.O.MS. 661/64/Agri. dated 5.10.1964 read as fifth paper above it was a stated that the Conservator of Forests has powers to accord technical sanction to silvicultural works only up to Rs. 25,000/-. It is clarified that the Conservators of Forests have full powers to accord technical sanction to silvicultural works and that they would continue to exercise the same.
- 3. The Chief Conservator of Forests has proposed that the powers of the Conservator of Forests to accord administrative sanction and arrange departmental execution of silvicultrual works may be enhanced from Rs. 25,000/- to Rs. One lakh, and that of the Divisional Forest Officer for the same from rs. 10,000/- to Rs. 25,000/-

4. Government have examined the proposal carefully and in supersession of all previous orders on the subject they are pleased to delegate the following powers to the Officers of the Forest Department in the matter of execution of silvicultural works:
