- (i) The delegation as per item (i) of Part I Financial is cancelled as the letter of credit system is now not in vogue.
- (ii) The delegation as per item (ii) of Part II Financial regarding the sanctioning of advertisement charges will be subject to Budget Provision (vide Note 1, item 1 of Appendix 14 to Tranvancore Financial and Account Code-volume (II)
- (iii)The following note will be added below item No.(vii) Part II financial, delegating powers to santion maintanance and petty construction and repair workers.
- Note:- Works above the limit of Rs. 1000/- (rupees one thousand only)should be taken by P.W.D or other Regarding Department.
- (iv) The powers delegated to the Administrative Officer regarding local purchase of stationery- vide item (viii) Part II- Financial will be subject to the additional condition that Store Purchase rules are observed.
- (2) Government also wish to make it clear that no delegation to the Administrative Officer is necessary to withheld increments in view of the specific provisions in the matter in the Kerala Civil Services (Classification, Control and Appeal) Rules, 1960.

With reference to the Government order cited above, I am to offer the following remarks for your consideration.

- 1. Part II Financial item No.(1)
 The letter of credit system is now not in vogue. The delegation is therefore not necessary.
- 2. Part II Financial Item No.(II) Power to Sanction advertisement charges.

A condition that the delegation in subject to Budget provision (vide Note I item1 of Appendix 14 To:T.A Code Vl.II) may be added.

3. Part II Financial – item No. (vii) To sanction maintenance and Petty Construction and repair works.

The following note may be added.

Note:- Works above the limit of Rs. 1000/- should be taken by P.W.D or other Engineering /department.

- 4. Part II Financial Item No. (viii) Purchase of Stationery.
 An additional condition that the delegation is subject to store purchase rules may be added.
- 5. Part I Administrative- Item No. V to sanction increments.

It is not clear whether the Administrative Officer is empowered to withheld increments. If so a specific clause may be added to that effect and note that the provisions of Kerala Civil Service Clarification, Control and Appeal Rules should be observed before an order withholding an increment is a passed may be appended to that clause.
