[Copy Resolution F.No. 15011/1/76-Estt. (B) dated the 29<sup>th</sup> April 1976 from the Cabinet Secretariate (Department of Personnel and Administrative Reforms ) addressed to all Ministers/ Department under the Government of India, the standard rule for recruitment will henceforth be modified as follows:-

"A candidate for appointment to any Central Service or post must be:-

- (a) A citizen of India, or (b) a subject of Nepal, or
- (b) A subject of Bhutan or
- (c) A Tibetan refuge who came over to India before the Ist January, 1962 with the intention of permanently settling in India, or
- (d) A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka and East African countries of Kenya, Uganda and the United Republic of Tanzania (formerly Tanganyika and Zanzibar) with the intention of permently setting in India;
- (1) Provided that a candidate belonging to categories (b), (c), (d) and (e) shall be person shall be whose favor a certificate of eligibility has been issued by the Government of India.
- (2) Provided further that candidates belonging to categories (b), (c) and (d0 above will not eligible for appointment to the Indian Foreign Service.

"A Candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the Union Public Service Commission or other recruiting authority and he may also provisionally be appointed subject to the necessary certificate being given to him by the government."

## ORDER

Ordered that a copy of this Resolution may be communicated to all State Governments, all Ministries of the Government of India, etc.,and also that the Resolution be published in the Gazette of India.

[ Copy of Revolution F.No.15011/1/76- Estt.(B) dated the 29<sup>th</sup> April 1976 from the Cabinet Secretariat ( Department of Personnel & Administrative Reforms) addressed to All Ministers/ Departments of the Government of India etc., etc.] The Government of India have decided that in supper session of earlier instructions regarding the eligibility for appointment under the Government of India, the standard rule for recruitment will henceforth be modified as follows:-

"A candidate for appointment to any Central Service or post must be:-

- (a) a citizen of India, or
- (b) a subject of Nepal, or
- (c) a subject of Bhutan, or
- (d) a Tibetan refugee who came over to India before the Ist January, 1962 with the intention of permentely setting in India, or
- (e) a person of Indian origin who has migrated from Pakistan, Burma, SriLanka and East African Countries of Kenya, Uganda and the United Republic of Tanzania (formerly Tanganyika and Zanzibar) with the intention of permently settling in India;
  - (1) Provided that a candidate belonging to categories (b), (c), (d) and (e) shall be a person in whose favors a certificate of eligibility has been issued by the Government of India.
  - (2) Provided further that candidates belonging to categories (b), (c) and (d) above will not be eligible for appointment to the Indian Foreign Service.

" A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the Union public Service Commission or other recruiting authority and he may also provisionally be appointed subject to the necessary certificate being given to him by the Government".

### ORDER

Ordered that a copy of this Resolution may be communicated to all State Government, all Ministers of the Government of India etc., and also that the Resolution be published in the Gazette of India.
