### **ORDER**

In the G.O.read as first paper above, orders were issued for the reintroduction of the system of issuance of certificates to candidates who pass in full one or more of the Departmental and Account tests conducted by the Commission, discontinuing the system of publishing the full address of the successful candidates with their register numbers in the Government of Gazette so that the Departmental authorities may make necessary entries in the Service Books of the candidates concerned by referring to the relevant Gazette.. In the letter read as second paper, the commission has pointed out that because some administrative difficulties the required number of certificates could not be got printed in time and with a view to obviating the resultant difficulties to the candidates, has advised that the revised procedure of production of certificates issued by the Commission as proof of pass in Departmental and Account Tests for making entries in the service book may be relaxed temporarily. The commission has also advised that the production of certificates need be made applicable only in respect of Departmental Tests, the result of which are published after 1-4-1977 and that in the case of tests the results of which have been published prior to 1-4-1977, the former practice of noting the particulars of the tests in the service books with reference to the results published in the Gazette the original admission tickets of the candidates may also be allowed to be continued. Government is pleased to accept the advice of the Commission and order accordingly.
