S.R.O.No 527/78- In exercise of the powers conferred by subsection (1) of section 2 of the kerala public service Act 1968 (19 of 1968) read with section 3 thereof the Government of kerala hereby make the following amendment to the kerala state and subordinate service rules,1958 namely;-

AMENDMENT

In part II of the said rules in rules 10 in the provisions to clause (iii) of sub-rule (b) for the words “appointing authority shall appoint” the words “appointing authority may appoint” shall be subordinated.

Explanatory Note

(This note does not form part of the notification but is intended to indicate its general purport)

The word “shall appoint” used in the provision to clause (iii) of rule 10 (b) may appear to mean that it is mandatory for the appointing authorities to temporarily appoint every person advised by the public service commission even before verification of character and antecedents. Government had no intension that the appointing authority should give temporary appointment to a candidate advised by the public service commission before verification of character etc. if he has specific knowledge of existence of any criminal charge against that candidate. It has therefore been decided to substitute the words “may appoint/” for the words “shall appoint” so that the appointing authorities may not be under compulsion to appoint candidate of doubts antecedents until the verification reports are received. This notification is intended to achieve the above object.
