PUBLIC SERVICE – RETROSPECTIVE PROMOTIONS AGAINST VACANCIES REMAINING UNFILLED FOR WANT OF TESTS QUALIFIED HANDS – BAN ON PAYMENT OF ARREARS – LIFTED – ORDERS ISSUED

ORDER

In the G.O. read as the first paper above, it ordered that in cases where the passing of an examination or test confers on a Government Servant the title to any right, benefit or concession, such title should be deemed to have accrued on the day following the last day of the examination or test which he passed and where the examination or test can be passed in installments, the title to the .., benefit or concession would be deemed to have accrued on the day following the last day of the examination in the subject (s) in which he passed and that the above practice be adopted in Kerala State with passed and that the above practice be adopted in Kerala State with effect from 1-11-1956 so far as the drawal of increment was concerned. In the G.O. second cited, the above principle was extended for promotion to pasts not involving change of duties against vacancies remaining unfilled for want of test qualified hands, with effect from 28-9-1957 (namely, the date of G.P.R.Dis. No. 14356/87/PD), subject to the condition that no arrears of pay would be granted on account of such promotion.

2. Government are now pleased to order that the ban ordered in the G.O. read as second paper above on payment of arrears when retrospective promotions not involving change of duties are given against vacancies remaining unfilled for want of test qualified hands be lifted with prospective effect. However Government will have the discretion to allow or not to allow payment of such arrears on the merits of each individual case.
