NOTIFICATION

S.R.O.No. 1350/79.- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1960) , read with section 3 thereof, the Government of Kerala hereby make the following Amendments to the Kerala Service Rules, namely:-

C.S.No.367/79

1. (1) These rules may be called the Kerala Service (Amendments) Rules, 1979.
(2) They shall come into force at once.
2. In part I of the Kerala Service rules, for sub-rule (16 A) of rule 12 and the note there under the following rule shall be substituted, namely:-
“(16A) Last Grade Service:-

“Last Grade Service” means service in any post included in the Kerala Last Grade Service constituted by the Special rules for the Kerala Last Grade Service, published under G.O (P) No.82/ public (Rules) Department dated the 8th March, 1966, in Part I of the Kerala Gazette No.14 dated the 5th April, 1966, as amended from time to time, and includes service in any post declared by the Government to be a post in the Last Grade Service”.

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

Rule 12 (16A), Part I, Kerala Service Rules as it stands now does not actually define the term "Last Grade Service". The three sub-rules describe the term differently. The gist of the rule is that any service declared as Last Grade Service by Government will be treated as Last Grade Service. As the categories of posts belonging to Last Grade Service are listed out in the Special Rules for Last Grade Service, Government considers it no longer necessary to specify any post belonging to or not belonging to Last Grade Service in the Kerala Service Rules. Any post which has been specifically declared as belonging to Last Grade Service in the Special Rules or in any executive orders issued by the Administrative Department concerned will alone be treated as belonging to that service. The above amendment is intended to lay down the above position in the rule.
