NOTIFICATION

S.R.O.No.451/80 – In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof the Government of Kerala hereby make the following amendments to the Special Rules in respect of Kerala General Service published under notification No. G.O.(P) No. 464, public (Rules) Department dated the 28th November 1965, in Part I of the Kerala Gazette No 49 dated the 13th December, 1966 as subsequently amended, namely:-

AMENDMENTS

In the said rules,-

- (1) in sub rule (a) of rule 2 in the entries in column (2) against the category"3. Divisional Accountant", for Note (2) under entry (iii) in column (2), the following shall be substituted, namely:-
- (2) "If the required number of candidates are not available to fill up the vacancies to filled up under item (iii0 above, the deficiency shall also be made good by direct recruitment".
- 2) in the Table under rule 5, against the category "3 Divisional Accountant" in column (1) in item 2 of the qualification in column (3) against the method of appointment "By transfer from among U D Clerks of all Departments etc". in column(2) for the letters and word "U.D.Auditor" the following shall be substituted, namely:-
- "Senior Accountants/ Upper Auditor".
- (3) in rule 7, for sub-rule (b) excluding the provisos thereto the following shall be substituted, namely—
 - "(b) A person appointed to category 3 shall from the date on which he joints duty undergo practical training for a period of 18 months. On the successful completion of the training he shall be on probation for a period of one year on duty within a continuous period of two years. During the period of training a trainee shall be gives training allowance as fixed by Government from time to time".

Explanatory Note

(This note does not form part of the notification but is intended to indicate its generals purport)

According to the Special Rules for the Kerala Service issued in G.O.(P) No 464/PD dated 28-11-1966 U.D.Clerks of all Departments (including Assistants Grade I of the Administrative Secretariat and finance Secretariat and the office of the Kerala Public Serv ice commission and U.D. Auditors of the Local Fund Audit Department) and those above U.D.Clerks in the Non- Gazetted cadre are eligible for appointment by transfer as Divisional Accountant. The U.D.Clerks and L.D.Clerks of the Department of Treasuries have since been redesignated as Senior Accountant and Junior Accountant respectively. So, In order to make the redignated Senior Accountants and those above Senior Accountants in the non-gazetted cadre in the Department of Treasuries eligible for appointment as Divisional Accountant it is considered necessary to amend the social Rules. Again rule 7 (b) of the Special rules provides for practical training to persons appointed as Divisional Accountants. In 1976 Government have issued orders enhancing the training allowance. Suitable modifications to that effect are therefore necessary to the special rules. The Kerala Public Service commission has also advised that the Special Rules may be amended to the effect that if suitable candidates do not become available for transfer from the category of Junior Superintendent of the Public Works Department or Public Health engineering Department or from among U.D.Clerks etc. from other Departments, those vacancies may also be thrown open for direct recruitment to the post of Divisional Accountants. This notification is intended to achieve the above objects.
