Sub:- Recruitment to Public services- Reporting of vacancies to the PSC -Elimination of Delay- Instructions reiterated.

Ref:- 1. Government Circular No. 55419/SD1/86/GAD dated 19-4-1986.

2. Government circular No. 57209/SD4/86/GAD dated 25-8-1986.

The attention of all Heads of Departments and Appointing Authorities is invited the Government circulars cited, wherein they were directed that all vacancies should be reported to the Public Service e commission for advising candidates from the ranked list and the candidates, advised by the commission are appointed without delay. Government have been receiving complaints that in spite of these directions, the vacancies in the different categories of posts are not being promptly reported to the Public Service commission and that this adversely affects the chances of candidates included in the ranked list. In the judgment on OP No. 6894/86

The High Court has ordered as follows:-

"3. This court has repeatedly stated that every vacancy in every Department of the State which has to be filled up by candidates selected by the Public Service commission should reported forthwith to the public Service commission, and steps should be taken expeditiously to fill up such posts by selecting candidates through the Public Service commission. It is revealing that such directions had been disobeyed because, in the present case, the petitioners were continued in service for a period of four years, apparently without the vacancies being reported to the Public Service commission. This court is not inclined to countenance such disobedience of orders of this court. Nor is there any justification for granting any relief to the petitioners who were continuing in service in defiance of orders of this court, Neither of the two relief as sought by the petitioners can be granted. The Original Petition is, therefore, dismissed."

The instruction issued in the circulars cited are therefore once again reiterated and all the Heads of Departments and appointing authorities are directed to see that every vacancy, which has to be filled with candidates selected by the Public Service Commission, is reported to the P.S.C. If any vacancy remains to be reported to P.S.C it should be reported within 15 days.
