### **NOTIFICATION**

S.R.O.No 1659/87 – In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) The Government of Kerala hereby make the following rules to amend the Kerala Service (Divisional Accountants) Special Recruitment of Scheduled Castes/ Scheduled Tribes Rules,. 1981 published under notification G.O.(MS) No.221/81/Fin dated the 4<sup>th</sup> day of April, 1981 in Part I of the Kerala Gazette No. 17 dated the 28<sup>th</sup> of April, 1981, namely:-

#### **RULES**

- Short title and commencement- (i) These rules may be called the Kerala General Service (Divisional Accountant) Special Recruitment of Scheduled Castes/ Scheduled Tribes (Amendments) Rules, 1987.
  (They shall come into force at once.)
- 2. Amendment of the Rules:- In the Kerala General Service (Divisional Accountants ) Special Recruitment of Scheduled Casts/ Schedules Tribes rules, 1981, for rule 5, the following rule shall be substitutes, namely:-
- 5. Recruitment of Candidates:- Recruitment shall be made through competitive qualifying examination called "the Initial Recruitment Examination Divisional Accountants". The examination shall be conducted by the Public Service commission. The subjects and the minimum marks qualifying for a pass in this examination shall be as follows:-

## **Explanatory Note**

(This is not part of the notification, but is intended to indicate its general Purport)

In G.O (MS) No.221/81/Fin dated 4-4-1981, Government have laid down the rules for special recruitment from among the members of Scheduled Castes/ Scheduled Tribes to the post of Divisional Accountants in the Kerala General Service. In Rule 5 of the said G.O the subjects and the minimum marks qualifying for a pass in the Initial Recruitment Examination were also prescribed. Though the post of Divisional Accountants for special recruitment for notified twice and written examination conducted twice and written examination conducted twice by the Public Service commission, no candidate came out successful by securing the enquired minimum marks for all papers. Government therefore purpose to lower the minimum marks prescribed for a pass in each paper by 5 marks by amending suitably the rules for special recruitment of Scheduled Castes/ Scheduled Tribes to the post of Divisional Accountants in Kerala General Service, So that sufficient number of candidates will come out successful in the selective test. This notification is intended to achieve the above object.
