ORDER

According to the existing orders in the Government Orders read above, the candidates appointed as Typist-Clerk or Clerk-Typist should exercise their option to be included in the list of Clerks or Typists within one month from the date of their joining duty. Those who do not exercise their option within the time limit will be treated as L.D. Typist for purpose of further promotion.

2. In the letter fourth read above, the Public Service Commission has pointed out that the time limit of one month is too short for the newly recruited persons for taking a decision on their option. They have there fore advised that the time limit may be extended to six months. Government accept the advice of the Public Service Commission and order that the period allowed to exercise option to Typist Clerk or Clerk-Typist will be extended to six months from the date of their joining duty.
