ORDER

Representation were received by Government from the Public complaining that firewood was not available to the average consumer at reasonable prices.

Government therefore examined the question of supply of to the public through co-operative societies at a conference attended to by the Deputy Chief Minister Minister (Food & Agriculture) Secretary, Agriculture, Chief Conservator of Forests and the Deputy Registrar (Administration, on behalf of the Registrar). After discussion it was agreed that the concession extended to the Trivandrum Co-operative Distributive Society for distribution of firewood to consumers at a reasonable price (Rs. 24/- per ton at present) will be extended to cooperative societies which are in a position to take up the work and which are recommended as fir for the purpose by the Registrar of Co-operative societies or by the Deputy Registrar in the headquarter towns of the Nine District in the State.

The Registrar of cooperative societies will send up proposals recommending cases of cooperative societies which are able to do this work, to the Chief Conservator of Forests. The Chief Conservator of Forests will take sanction of Government for issue of fuel coupes to the societies.

The petitioners are referred to the Registrar of Co-operative Societies for further information in the matter.
