The right of collection and removal of residual tree growth from Tharathala Sub Coupe No.A and B in Kothamangalam Range was notified for sale by the Divl. Forest Officer, Malayattur fixing the date of auction as on 24-2-70 at 3 p.m. The notification was published in Government Gazette dated 3-2-70 on pages 88 to 91 of Forest sheet and in Malayalam Dailies Kerala Nadu dated 16-2-70 and Kerala bhushanam dated 17-2-70. The auction was conducted by the Divl. Forest Officer, Malayattur at the fixed time and the sales were knocked down in the names of the highest bidders for the lumpsum prices as shown below.
