

Proceedings of the Conservator of Forests,
Central Circle, Trichur.

Sub: Auction sale of tree growth to sub coupe No.2 of Ayyappan coil evicted area coupe No.VII – auction dated 28-2-74 – confirmed.

Read: Letter No.C7-5968/73 dated 4-3-1974 from the Divl. Forest Officer, Kottayam.

Order No.KT.22067/73 dated 7-3-1974

In pursuance to notification published in Gazette dated 12-2-74, page 101 of Forest Sheet and in dailies Keralabhooshanam dated 20-2-74 and Deepika dated 21-2-74, the reauction of the sale of right of collection and removal of tree growth except Teak and Rosewood available in sub coupe 2 of Ayyappancoil evicted area coupe No.VII was conducted by the Divl. Forest Officer, Kottayam on 28-2-1974 at the risk and loss of Shri. M.K. Aly, Janeeva Saw Mills, Perumbavoor who bid the coupe in the auction held on 21-11-73 but failed to remit the balance 1/3 bid amount and security and to execute the agreement. Besides publishing notifications as stated above, notice of reauction was issued to the original bidder Shri M.N, Aly

It is reported by the Divl. Forest Officer in the letter cited above that seven persons deposited earnest money and participated in the auction. The sale was knocked down in the name of the highest bidder Shri M.K. Sayed Mohammed, Machatlu House, Medical P.O., Perumbavoor for a lump sum of Rs.18,600/- (eighteen thousand and six hundred only). The departmental valuation fixed for the sub coupe was Rs.8,200/- Since the price offered is higher than the departmental valuation and since the area has to be got cleared for planting during 1974, the Divl. Forest Officer has recommended to confirm the sale.

Having convinced myself that there hasw been adequate publicity for the sale and keen competition among the bidders and that the price offered is reasonable, I Shri K.G. Vasudevan, Conservator of Forests, Central Circle, Trichur confirm the sale in the case of Shri M.K. Sayed Mohammed for the highest bid amount of Rs.18,600/- (Eighteen thousand and six hundred only) offered by him.

The Divl. Forest Officer will pursue further action and to get necessary agreement executed by the bidder and to recover the loss in the sale from the original bidder as per the terms and of the sale action.
