The right of collection and removal of tree growth, except Teak and Rosewood, available in sub coupes IV, V and VII of Ayyappancoil evicted area coupe No.VII was notified by the Divl. Forest Officer, Kottayam for reauction to be held on 30-1-1974 at the Divisional Forest office, Kottayam as per notification pub lished in gazette dated 22-1-1974, page 47 of the Forest sheet and in dailies Kerala Bhooshanam and Deepika dated 23-1-1974. The auction was condicted on 30-1-1974 as notified. It is reported that ten persons deposited earnest money and participate in the auction. These sub-coupes were originally put up for auction and sold on 29-11-73, but the sale was cancelled in this office proceedings on even nso. dt.1-1-1974 as the offers received were not considered to be attractive.
