Sub: Cost of tender forms enhancement — reg.

As per the Kerala Forest Code, the tender forms, tender notice and agreement forms for civil works prescribed for the public works Deptt. are generally applicable to the Forest Department also (10-8-2-VII para 129). It is not clearly stated whether this is applicable in the case of works relating to timber extraction also and if so the price of tender forms to be followed. However, so far the price of tender forms adopted in PWD has been followed in Forest Deptt. also.

Kind attention is invited to the Notification in G.O.(P) No.177/73/PW dt. 20-8-73, in which the enhanced rates for tender forms have been ordered in respect of Kerala Public Works Deptt. Now a doubt has arised whether thiws rate has to be followed by Forest Deptt. without a specific order to that effect. The existing rate was fixed in G.O.Ms.419/PW dt.8-11-60 got public works Deptt. In order to follow the some rate in Forest Deptt. G.O.Ms.460/61/Agri.dt.10-561 (copy enclosed) was issued. Therefore it may be clarified whether the enhancement ordered in PWD can be followed now or a separate order is necessary in respect of the Forest Deptt. In this connection, I have to point out the Conservator of Forests, Quilon has already directed the Divl. Forest Officers in his Circle to follow the enhanced rate. I recommend that the enhanced rate may be ordered to be followed in this Department also. Early orderes are solicited in the matter.
