

PROCEEDINGS OF THE CONSERVATOR OF FORESTS, CENTRAL CIRCLE, TRICHUR.

Sub:- Extraction of timber from Upputhodu coupe III B — agreement dated 29-5-72 with Sri.P.K.Mohanana — transfer of contract to Sri. P.K. Prabhash — sanctioned.

ORDER ON KT-31118/73 dt. 5-3-1974

As per this office proceedings on KT-13018/71 dt.15-5-72, the work of extraction of about 5658 cum. of timber from 4008 marked trees in Upputhodu assignable area coupe No.III B in Ayyappancoil Range and delivery of the same at Vetticad Depot was awarded to Sri.P.K. Mohanana, Vattakunnel, Erayilkadavu, Kottayam at the tendered rate of Rs.123/- (One hundred and twenty three only) for delivery of each coupe of timber. Accordingly Sri. P.K. Mohanana executed an agreement with the Divl. Forest Officer, Kottayam on 29-5-72 furnishing a security deposit of Rs.20,000/-

The Contractor Sri. P.K. Mohanana has now applied for permission to transfer the work in the name of Sri. C.K. Prabhash, Mohana Sawdham, Market Landing Kottayam as he is unable to carry out the work due to financial difficulties and illness and has submitted the petition read above as first paper jointly with Sri. C.K. Prabhash. In the petition Sri. C.K. Prabhash has expressed his readiness to take up the work. The Divl. Forest Officer, Kottayam in his letter read above as 2nd paper has recommended to transfer the Contract in the name of Sri. C.K. Prabhash with all assets and liabilities of the contract.

In the circumstances stated above and in view of the provision contained in condition 21 of the agreement dt.29-5-72 executed by Sri. P.K. Mohanana, I Sri. K.G.Vasudevan, Conservator of Forests, Central Circle, Trichur hereby accord sanction for the transfer of the Contract entered into by Sri. P.K. Mohanana in the name of Sri.C.K. Prabhash, Mohana Sewdham, Market Landing Kottayam, provided the transferee will execute a fresh agreement with due security embodying all forums and conditions of the original agreement dt.29-5-72 and providing time till 28-5-1974 i.e. the period of the original contract.

The security furnished by the transferer will be released to him on remittance of fresh security and execution of agreement by the transferee. But the retention amount of K.V. if any available, should not be released to the transferer.
