ORDER

Section 10-9-1(vii) of the Kerala Forest Code Volume lays down as follows:

- "(vii) Advertisement in the gazette and to local dailies is necessary in the case of all important tenders and suction. Besides, notifications may be displayed in Taluk Offices, Villages Offices and Panchayat Offices of the locality as far as possible. Copies of notifications may be sent to registered contractors and other persons known to be , or likely to be interested in to the sale or tender, whether registered contractors or not. Copies of notifications may be sent to neibouring divisions for distributions among interested persons"
- 2. In G.O (P) No. 7/85/PR dated 12-10-1983 read as 2nd paper above, the General Administration (Public Relations) Department prescribed procedure governing the policy of releasing Government Advertisements. Tender Notices, Auction Notifications etc. come under Routine Advertisements as per the above Government Order. Guidelines were also prescribed for the release of Routine advertisements to dailies based on circulation of the Daily and amount of the tenders etc, as well/ As per those guidelines, advertisements for the tenders amounting to Rs. 10/lakh and above can be released for publication in one Malayalam Daily having adequate circulation in the region, and if necessary on English Daily through the Director of Public Relations.
- 3. In the letter reads as first paper, above, the Chief conservator of Forests has brought to the notices of Government that Advertisements or notifications on tenders and Auctions for removal of timber or tree growth in Coupe etc. are not published in two dalies as required under the State Viz Kerala Forest Code Volume I as mentioned in para (1) above, but published only in one daily as per the Government order read above,
- 4. Government have examined the question in detail and they are of the view that the rule under the Kerala Forest Code will prevailing the executive orders issued by Government in the G.O read as above, Hence they are pleased to order that Advertisement in respect of notifications on tenders and auctions for removal of timber or tree growth in coupes of Forest should be published in two dailies as laid down in action 10-9-1 publicity-(vii) of the Kerala Forest Code Volume I.
