#### **ORDER**

Government have examined the question of enhancing the power delegated to the officers of the forest Department in respect of civil works undertaken in the forest Department and they are pleased to order that the following powers be delegated to the officers of the Department .

#### 1. Powers to accept tenders and axcess rates:

<u>Chief conservator of forest:</u> Full powers to accept tenders for civil works without monetary limit for which technical sanction is available, overall excess of 15% and individual excess unlimited.

<u>Conservator of forests:</u> To accept tenders for civil works for which he has accorded technical sanction with overall excess unlimited .

### 2. Power to accord administrative sanction to Estimates of original works:

<u>Chief conservator of forests</u>: To accord administrative sanction to estimates up to Rs. 1 Lakh. <u>Conservator of forests</u>: To accord administrative sanction to estimates up to Rs. 25,000/-

## 3. Powers to sanction survey reports of buildings:

 $\frac{\text{Chief conservator of forests:}}{\text{Conservator forests:}} \quad \text{To sanction survey reports of assessed by the public works Department.} \\ \frac{\text{Conservator forests:}}{\text{Conservator forests:}} \quad \text{To sanction survey reports of building up to Rs. 10,000/- based on the book value or the value assessed by the public works Departments.} \\$ 

In case where book value is not known the valuation should be got done by public works Department before preparing the survey report .

#### 4. Power to waive calling of tenders:

Chief conservator of forests: TO waive calling of tenders up to Rs. 5,000/-

Conservator of forests: To waive calling of tenders up to Rs. 1,000/-

The orders now issued supersede all the previous orders on the subject.
