In continuation of this office letter even no. dated, 2.4.1975 the following directions are issued for the formation of teak and softwood nursery beds in view of the high involved in the provision of bamboo thatties.

2. The benefits to be accrued from during away with bamboo thattie will more than out weigh the disadvantages caused by it and therefore it is directed that bamboo thatties need be provided only in very heavy rainfall areas and steep slopes, which can also be avoided if proper sites are available.

Even on sloping grounds coming under the heavy rainfall zones, thatties need be provided only on the lower slopes

3. To affect proper and efficient drainage of water the length of beds may be reduced from 40 ft. to 3 metre so that the beds can be saved from being washed off during the raining season.

4.The rate of formation of beds as above may be taken as twice that given in item III of the Minimum wage notification (i.e. For preparation of seed bed nursery for Eucalyptus) and the specification given for raising standard Teak nurseries may be followed with the change that instead of providing side thatties. The sides may rammed and compacted, in the same way as provided for Eucalyptus seed bed nursery and that the length of beds should be reduced to 3 metres. The rates provided in item "IIIa" of the min. wages notification should not be adopted for this works.

5. In case bamboo thatties are proposed for the lower sides of beds, the lower halves of the two sides (width portion of beds) should also be provided with thatties so that there will be 44 rft. Of thatty for each bed. In such cases the rates allowable will be the average of items III a and 2 x IIIg plus the cost of delivery etc., of bamboos and pegs to the required quantity.
