ORDER

Over the past 3 decades, various organizations under the Kerala Government have generated enormous amount of spatial/attribute data pertaining to the State. Lack of proper mechanism to monitor data generation and utilization has not only resulted in duplication of the work but also led to multiplicity of standards in terms of scale, projection, content, formats, quality etc. Thus, data inventory and data sharing is absolutely essential to avoid duplication, erroneous representation and wastage of resources. Inconsistency in layers creates significant issues when data from different sources have to be used together. To avoid these issues, a single standard has to be specified and all available data has to be converted in to the globally acceptable interoperable standard, so that the designated agencies can access the data without any conflicts.

For enabling web-based data sharing, as per the orders referred to above the Government granted approval for setting up of the Kerala State Spatial Data Infrastructure (KSDI) by establishing, Web-based portal and a clearing house. The geoportal is proposed to provide an interactively connected framework built on a Service Oriented Architecture (SOA), implemented by means of interoperable OGC-complaint web Services. The portal is used as a starting point and a web gateway to access the geospatial data content. The geoportal would have capability to handle data storage, retrieval and update and geoprocessthe geospatial information through web-based services. With interactive communication facilities enabled in KSDI geoportal, group of decision makers can get connected and take appropriate decisions through the web-based application programmes.

The KSDI is designated as the central repository of the state-level digital data and will be connecting point between the data producing agencies and users for data sharing. Based on the G.O. referred as 2nd paper, the Government identified the following organizations as data providing agencies that will have an interface with KSDI for uploading/sharing of data:
