ORDER

As per the G.O read as 2nd paper above, Government have sanctioned non functional grade to IFS officers in Pay band-3 and Pay Band-4. But as per letter read as 4th paper above the Principal Chief Conservator of Forests has pointed out certain errors in the said Government Order.
