## II Eligibility for admission to Master's Degree Programme

---

A basic degree with an aggregate of least 56.25% marks or an O.G>P.A. of 2,50 out of 4,00 from the concerned Faculty of the Kerala Agri. University or a qualification recognized by Kerala Agri.University as equivalent there to. In the case of Sc/St candidates a basic degree in the Faculty concerned is the minimum requirement.

1. Agrl.Economics: A basic degree in Agriculture /Horticulture/ Veterinary & Animal Sciences.
2. Agrl.Engineering: A degree in Agrl.Engineering or a degree in Engineering (Civil or Mechanical).
3. Agrl.Statistics: A degree in Agriculture/Horticulture/ Veterinary & Animal Sciences or B.Sc. in Mathematics or Statistics.
4. M.F.Sc.Aquaculture/Fishery Biology: B.F.Sc Degree
5. M.Sc (Food Science & Nutrition): B.Sc.(Ag./B.Sc(Hort)/B-V.Sc. B.F.Sc or a basic degree in Home Science with 56.25% marks.
6. M.Sc (C&B: A basic degree in the Faculties of Agriculture/Vet., & Animal Sciences/ Fisheries or B.Sc. (C&B) of Kerala Agrl. University or a qualification recognized by the University as equivalent thereto.
7. M.Sc.(Forestry): A basic degree in the Faculties of Agriculture Veterinary & Animal Science or candidates with either B.Sc. (Forestry) or a University

degree with a higher grade certificate from Rangers Colleges or with a diploma in (Forestry) from State Forestry Colleges or Indian Forest College, Dehra Dun.

The Course in Forestry involves practical field work recurring consideration

8. For the Kerala Agricultural University employees a basic degree in the concerned Faculty or B.Sc. in Engineering (Civil or Mechanical) for M.Sc. (AG.EnGG) shall be the minimum requirement for admission to Masters Degree Programme.
9. The ICAR/State or Central Govt. employees will also be considered at par with K.A.U. employees for admission in case the applications of such candidates are recommended by the ICAR the constituent units of the Council. State or Central Government. Concerned.

## III Eligibility for admission to ph. D. degree Programme

---

1. A Master's Degree in the discipline from the concerned Faculty of K.A.U. or a qualification recognized by the said University as equivalent thereto.

IV. Departmental Candidates.

The candidates sponsored by the Department of Agriculture, Animal Husbandry, Fisheries and Development should have a minimum service of 3 years and 5 years on the date of application for admission to Master's and Doctorate Degree Programme respectively. Intending candidates will have to submit their applications through the Heads of Departments concerned.

V System of Education  
-----

Trimester system of education will be followed for all the courses referred To above.

VI Duration of Course  
-----

The minimum duration of all post-graduate to programmes will be trimesters (2years ). However the minimum duration of the M.Sc. (Ag.Stat.) programme shall be 7 trimesters (about 2 years and 4 months).

Filled in applications with a consolidated application and registration fee of Rs.20/- (Rupees twenty only) (non-refundable) in cash payable at the Kerala Agri.University Office or by remittance through non operative collection account pay-in-slip of K.A.U. available at the branches of S.B. T. and receipt (original of the pay in slip) therefore attached to the application in proof of remittance of the prescribed fee should reach The Registrar not later than 15-4-86. Demand Draft in favor of then Comptroller. Kerala Agricultural University will be accepted only in cases of applications from outside State candidates. Money order/Cheques/Postal order/ Chelan receipts etc. will not be accepted .
