ORDER

In the meeting held by the Chief Secretary on 27-7-1982 regarding Forest Clearance for Hydro Electric projects and transmission lines, it was decided, among other things, that a Liaison Unit consisting of an Assistant Conservator of Forests and Assistant Executive Engineer (Kerala State Electricity Board) should be set up to help the co-ordination Committee and that the staff for this purpose may be allotted by the Forest Department and the Kerala State Electricity Board, respectively. In the letter read above the Chief Conservator of Forests has proposed to spare the services of Sri.M.V. Kuruvilla, Divisional Forest Officer, Timber Sales Division, Perumbavoor for this purpose, pending creation of a post of Assistant Conservator Forests. Government have examined the proposal of Chief Conservator of Forests and they are pleased to order as follows:

- 1) Sr. M.V. Kuruvilla, Divisional Forest Officer, Timber Sales Division, - Perumbavoor is transferred and posted as Assistant Conservator of Forests on working arrangement. He will work in Chief Conservator of Forest office and liaise with Kerala State Electricity Board.
- 2) Sri. M.M. Aboobacker, Assistant Conservator of Forests, Malayattoor Division is transferred and posted as Divisional Forest Officer. Timber Sales Division, perumbavoor vice Sri. M.V.Kuruvilla transferred.
