## **ORDER**

The President Sri . Ramakrishna Advaita Ashrama, Kalady has stated that a narrow belt of forest lands at Kalady lying on either side of their holding in Sy. No. 35/1, Manjappara Village is also required by the Ashrama for the beneficial enjoyment of the land already in the possession. But Government in their letter read as second paper issued instruction to the Chief Conservator of Forests to take steps for making available the above land ie, about 5 acres in extent for settling landless poor people.

On reconsideration of the matter Government feel that the above land should also be handed over to the Ashrama for their use. Therefore in super session of the instructions already issued, sanction is accorded for the discreservation and transfer of the land in question to the Revenue Department for allotment to the Ashrama. The terms and conditions of the allotment of the land will be the same as those fixed for the land already leased out to them. The tree growth if any in the land will be disposed of by the Forest Department before the land is transferred to the Revenue Department.
