## <u>ORDER</u>

In the G.O. read as first paper above a procedure was formulated for the sale of trees in occupied areas to the occupants. The Chief Conservator of Forests in his letter read as second paper has reported that there was some difficulty in the actual application of the above orders in deciding the species to which schedule rate minus working charges is to be realised and also in deciding the inferior species. The Chief Conservator of Forests has stated that schedule rate can be made applicable only to depot delivery size timber and tree species and cannot be applied to any tree or timber of lower girth. He has reported that for the purpose of valuation of all trees (except teak, rosewood, Ebony and Sandal wood) of and below 48" of depot delivery species and all other species irrespective of girth which are not depot delivery species may be treated as inferior species. He has also recommended that all species of trees other than the species noted below may be approved as inferior species:

- 2. The Chief Conservator of Forests has also stated that trees not required by the occupants for bonafide use including teak, rosewood, Ebony and Sandalwood will be disposed of by the department as per the usual course of timber extraction process and sisposal of residual treegrowth.
- 3. In the circumstances stated above Government accept the recommendation of the Chief Conservator of Forests and they order accordingly.
