**ORDER**

In the Memorandum reads first paper above the Perimachira sastha temple Governing committee, Vazhani, Trichur District has requested for assignment on lease or registry of an extent of one hectare of land in sy. No. 407/pt of Manalithara Vilalge , Thalappilli Taluk Trichur (District) in favor of the Temple. The land is under the Control of the Public work (Irrigation) Department. The Chief Engineer (Irrigation) and the Chief Conservator of Forests have no objection to assign the land to the temple authorities. The District Collector, Trichur has proposed land value at Rs. 10/- per area based on document No. 578/66 of Sub registry office, Wadakkancherry. The Board of Revenue has recommended registry of the land in favour of the Devaswom.

In the Circumstances, sanction id accorded for transfer of one hectare of land comprised in sy No. 407 of Manalithara village Talappalli Taluk to the Revenue Department and for the assignment of the said land in favour of the Perinchera Ayyappan Kavuv Devaswom Vazhani, on realization of land value at Rs. 10/- per acre subject to the following conditions.

1. The land should be utilized only for the activities and expansion of the Temple.
2. The land should not be alienated by way of gift sale mortgage etc. Without the previous sanction of the Government.
3. The Irrigation canals and the road passing near the land should be kept in

- tact and without causing any damage to the bank of the Irrigation canals.
4. The land shall be resumed by Government if any of the conditions of registry is violated
