## ORDER

In the Government Orders read as 1st & 2nd paper above, it has been ordered that Patient Employees working in Health Services Department will be treated as Part Time Contingent employees. In the Government contemporary as 2nd paper above orders were issued revising the scale of pay and allowances of State Government employees and Teachers, where in scale of pay has been introduced to Part Time Contingent employees for the first time. But it has come to the notice of the Government that the scale of pay sanctioned to Part Time Contingent employees are not allowed to Patient Employees in Health Services Department despite there is orders in vogue as referred above.

Therefore, Government are pleased to order that the scale of pay allowed to Category III of Part Time Contingent employees ie, ₹ 4250-6700 as per para 9 of the Government Order read as 2nd paper above is also applicable to Patient Employees working in Leprosy Hospitals and Sanatoriums under Health Services Department. The pay of Patient Employees shall be regulated as per the provisions laid down in para 9 of the Government Order read as 2nd paper and Circulars read as 3rd & 4th paper above.

Accordingly the designation 'Patient Employees' shown under the caption 'LEPROSY' and the footnote 'd', appearing on page 146 of the G. O. read as 2nd paper shall stand deleted.

This Order will take effect from 1-7-2009.
