**ORDER**

In the G.O. read above, it was ordered that a lease rent Rs.615/- per hectare per annum will be realized from the Kerala State Electricity Board and other Government owned commercial undertakings for forest lands lease out to them for their years from 18-12-1981 to 17-12-1984. The lease period expired on 17-12-1984. The Chief Conservation of Forests in his letters read above has submitted proposals for revision of rate lease rent with effect from 18-12-1984 for a period of three years.

2. Government having considered the proposal in detained are pleased to order that lease rent for Kerala State Electricity Board and other Public Sector undertakings at Rs.615/- per annum will be continued for the three year period up to 17-12-1987.

The Chief Conservator of Forests will take timely action to revise the rate of lease rent for the next three years from 18-12-1987.
